Protecting Public Lands: We watchdog the agencies in charge of public lands and we call for sound management decisions. We advocate for restoring wild, natural habitats and do hands-on stewardship. We organize volunteers to support the Forest Service through boots-on-the-ground activities.
-Nine program staff devoted full-time or part-time to "forest watch", restoration monitoring, legal advocacy, community engagement, agency collaboration, and stewardship
-In 2014, our work expanded to include eight Southeastern states where we monitor the management of public lands
-Volunteers gave 4000 hours to stewardship in 2014
Championing Wilderness: Wild South is working to create new wilderness areas in the South and to take care of the ones we've got. We work with diverse partners to identify

the best places for new wilderness areas and rally the public to support them. We also send volunteers into wilderness areas as volunteer rangers.
-Seven program staff devoted full or part-time to wilderness stewardship, wilderness volunteer recruitment & management, wilderness advocacy, and public outreach
-2014 marked the 50th Anniversary of the passage of the Wilderness Act, therefore Wild South organized and participated in a number of related events
-In 2014, Wild South engaged 65 volunteers in wilderness stewardship providing 2,100 hours of volunteer service equaling \$48,447 in in-kind contributions
Protecting Cultural Heritage: Wild South has partnered with the Eastern Band of the Cherokee to explore and communicate their history in the Southern Appalachians- including an online interactive map documenting over 500 miles of historic Cherokee trails

-Two program staff devoted full-time to cultural heritage protection, Indian trail inventory, historical record collection and archiving, community outreach, and collaboration with agencies
-New funding sources were secured in 2014 and Wild South represent cultural heritage interests as part of the Forest Planning process in NC
Defending Wildlife: Wild South protects the incredible biodiversity of our region through research, education, and advocacy. We support field research to advance conservation science. We provide wildlife education to over 3,000 kids each year. We also advocate for legal protection for wildlife that needs it.
-One staff devoted part-time to this program engaging interns and community volunteers.
-Our Hellbender Research Project proved fruitful in 2014 as nest boxes that were built and installed in 2013 were inhabited for the first time.


